

# Mailing the NRA News

In order for the NRA News to get a third class mailing permit and the substantial decrease in postage rates that we get, it is necessary to pre-sort the newsletters to make it easier for the Postal Service to speed the newsletter on to you. We have come up with some interesting statistics because of that pre-sorting.

The mailing permit does not, however, allow your newsletter to be forwarded should you move or otherwise have an address change. All these things save the NRA over \$200 per

month in postage.

The pre-sorting rules are quite complicated, having to do with zip codes, but it is interesting to note where all the newsletters go.

The majority go to eastern Montana. About 200 go to areas where the zip code begins with "590" and to the city of Billings itself.

If there are 10 or more newsletters being mailed to the same zip code number (or town) they are mailed direct. Some of the towns which have 10 or more newsletters being mailed direct are, of all places, Melstone, and Roundup, Hardin, Miles City, Lewistown, Powell, Wyo., and Billings.

Fifty newsletters go to Canada and First Class postage must be paid on these. One hundred six newsletters go to Wyoming alone, and 92 are mailed to "Mixed States" such as Idaho, Oregon, Washington, Utah, North Dakota, South Dakota, Nebraska, Colorado,

Oklahoma, Arizona and others.

The fewest number of newsletters go to the zip code "599," Kalispell area, where only five go, and one of those is the Coors distributor in Kalispell. The other zip code areas in western Montana where the MRA reigns supreme, are also "short." Last month we mailed out a total of 824 newsletters.

We used to sort the newsletters on our living room floor, making a pile for each zip code area, and then sorting them from there. It took us nearly 8 hours, our whole family working, to label, sort, count and bundle the

newsletters for mailing.

Since last June we have used an addressograph machine at the publisher's for mailing. Each person has his own "plate," and these plates are sorted into zip code areas. So the newsletters are sorted as they are addressed. This cuts down the man hours needed to mail the newsletter to about three hours.

However, don't ask us for someone's address unless you know their zip code, because that's how the "plates" are sorted. We need your address changes when you move because your newsletter will not follow you. Let us know when you move. It saves lots of gray hair!

#### **COORS MEETING**

On Feb. 27, 1981, I attended a meeting with the Coors people in Denver. Representing Coors were Jim Wildman, Shelly Burmeister and Mike Hudson. The regional rodeo association representatives were from Montana, Arizona, Nebraska, Utah, New Mexico, Wyoming and South Dakota.

It was a very informative meeting with Coors explaining the wide variety of promotional material available through their local distributors. Some of the items they have available at no cost to the rodeos are:

(A) Program covers

(B) Window streamers, personalized for each rodeo.

(C) Contestant numbers

(D) Directional signs for use on the rodeo grounds.

(E) Barrel decals and place mats for use at restaurants, etc.

When ordering items from Coors that are personalized, they stressed the importance of giving them at least 60 days lead time, so order early! For committees who haven't made use of this program it appears this could really help out on a tight advertising budget.

Coors will forward a tentative list of our rodeos to their distributors in the form of a rodeo

calendar in April. Work with your Coors Distributors!

We also discussed Coors involvement in open rodeos. Their purpose is to support regional rodeo, however, they will honor present committments to open rodeos.

#### 1981 FINALS

Our 1981 Finals showed a profit to the NRA of \$4,750.00. From the way the weather treated us on opening night, I feel this is very good news and speaks well for all the hard work put in by the people associated with the finals. Super job.

#### GOOD NEWS

1981 Rule Book Changes

The 1981 rule book is in the process of being printed. In the meantime, to assist you in preparing for the upcoming rodeo season and to help you in taking the judges test, the changes in the 1980 rule book as voted on by the NRA Board of Directors in February, are

printed here.

Some of the highlights and major rule changes concern: entry fees - minimum entry fee has been raised from \$25 to \$35 to further enhance rodeo payoffs; turnouts; day money; time limits on timed events have been eliminated for the finals only; and many others. Please read the rule changes here and when the new rule book comes out. "Ignorance of the law is no excuse."

1. On Page 9, No. 9, add this sentence to the end of the paragraph, "If a proxy vote is used, a signed, notarized consent from the director

must be sent to the NRA office."

2. Page 4, No. 4, shall read as follows: "It shall be the duty of the board of directors to work to obtain rodeos and they shall work with every effort with rodeo managements.'

3. Page 6, No. 15. "Junior Membership - \$10. Does include subscription to the newsletter.

- 4. Page 6, No. 15, was reworded, but essentially says the same, that is, that stock contractors must have a regular membership card in order to compete, along with the stock contractor's membership fee of \$40. Also in the same rule, No. 15, in paragraph six, the words, "Contract Acts and Professional Promoters," will be deleted.
- 5. Page 7, No. 10, shall read as follows: "It will be compulsory for any Association member to ride in grand entries. A \$10 fine may be assessed any member who refuses to abide by said rule."
- 6. Page 7, No. 3, shall read as follows: "A minimum of \$50 purse a performance in all adult events is required with a minimum of \$35 entry fees per person, per event, plus stock charge of \$4 per adult event except ladies barrel racing.

7. Page 8, No. 5, shall read as follows: "Any rodeo co-approved with another association must be brought before the board of directors

or the advisory board for approval."

8. Page 10, No. 15, shall read as follows: "The decisions of the judges, flagmen, secretaries and timers who have been accepted by the association shall be final and no protest by the contestants will be permitted unless incompetence is proven."

9. Page 10, No. 23. This entire rule has been removed, and several have been added, both in its place and at various places throughout the

A. A contestant turning out in any event

may contest in the rest of his events plus payment of his turnout fees. No stock shall be brought back after turning out.

B. A contestant turning out in any event will pay a fine matching the entry fee for each

event turned out.

C. The buddy system will be limited to two contestants per event, but six people can be on one buddy plan.

D. Turnout fees will be sent to the NRA office and applied to the finals purse.

10. Page 14, No. 3, shall read as follows: "A rodeo will pay day money if there is a minimum payoff of \$1,500 per event, \$3,000 in the team roping, when the entries close. The three per cent will be taken off the pay off before any breakdown is made. There is no ground money paid on any day money. There is no day money paid in Junior events.

Day Money Formula

1 - 5 contestants: first gets 100%.

6-11 contestants: first, 60%, second, 40%. 12 - 17 contestants: first, 50%; second, 30%; third 20%.

18 - 23 contestants: first, 40%; second, 30%,

third, 20%; fourth, 10%.

24 - 29 contestants: first, 37%; second, 27%; third, 19%; fourth, 10%; fifth, 7%.

30 - 35 contestants: first, 34%; second, 26%; third, 18%; fourth, 10%; fifth, 7%; sixth, 5%.

Payoff will be four monies unless go-around payoff exceeds \$750. Five places will be paid if the payoff is \$750-\$1500; six places, \$1500 -\$2500; 8 places, \$2500 - \$5000; 10 places, \$5000 to \$8000; and 12 places, \$8000 - up.

Pay off split is as follows:

Four places - 40%, 30%, 20%, 10%. Five places - 37%, 27%, 19%, 10%, 7%. Six places - 34%, 26%, 18%, 10%, 7%, 5%. Eight places - 30%, 24%, 17%, 10%, 7%,

5%, 4%, 3%. Ten places - 25%, 20%, 17%, 10%, 8%, 6%,

5%, 4%, 3%, 2%.

Twelve places - 22%, 17%, 14%, 10%, 9%, 7%, 6%, 5%, 4%, 2%, 1%.

A. On three head of stock the average will be one and one half times the go-around money in all of the above events.

B. On four head of stock the average will be twice the go around money in all of the above

C. On five or more head of stock the average will be three times the go around money in all of the above events.

D. The average will never exceed three

times the go around money.

11. Page 14, No. 4, shall read as follows: "No shows are not figured into the payoff. When they are collected they will be added to the year end finals."

1981 Rule Book Changes

12. Pages 14, 15, No. 8, shall read as follows: Three per cent (3%) shall be held out at the payoff (prize money and entry fee), one per cent (1%) to go to the Association and two per cent (2%) to the association finals rodeo prize money. The three per cent (3%) shall be taken off the total payoff before any payoffs are made.

13. Page 15, Art. VIII, No. 1, shall read as follows: "Contestants may be fined and/or disqualified for any of the following offenses during a paid performance or slack. Contestants can be disqualified only by agreement of the rodeo judges and the arena director. A majority decision of the three will decide."

e. (reworded) "Refusing to contest on an

animal drawn for him."

14. Page 15, No. 2. Delete the entire rule. 15. Page 15, No. 3, shall read as follows: "When a contestant is drawn in the slack he

will be notified when the slack begins during call backs."

16. Page 16, No. 6. Delete the entire rule. 17. Page 16, No. 10, Delete the entire rule.

- 18. Page 17, No. 12, Delete the entire rule. 19. Page 17, No. 13, add this to end of paragraph. "Judges should bring the complaint to the stock contractor's attention, and if proper action is not taken a fine will be applied."
- 20. Page 17, No. 4. Please insert "8" instead of the "6."
- 21. Page 18, No. 9. Please add this sentence to the paragraph: "If two contestants enter the team roping separately as two teams and they end up roping together, they are still responsible for a partner's entry fee."

22. Page 18, No. 18, Please add on this sentence, "There are no time limits set in the

timed events at the finals."

23. Page 19, No. 1, shall read as follows: "Positions must be drawn in all events before the stock draw. There will be no placing of contestants. All rodeos will be traded out unless otherwise listed."

24. Page 19, No. 2, shall read as follows: "Stock contractors shall bring at least three head of stock in the timed events into the chute according to position drawn at the start of each

performance or slack."

25. Page 19, No. 2, the first sentence should read as follows: "No shows are not figured into the payoffs." (continue on until the last sentence and it shall read as): "There will be a five day waiting period, from the day of the rodeo, after the doctor's or vet's release, complete with physician's name, address and phone number, is sent into the office before a contestant can compete in the next rodeo."

26. Page 24, No. 7, Delete the second sentence which states, "Barrier judge is to use the 10-foot barrier rule only as an indicator and

not a set rule." and in its place add: "The 10-foot barrier rule being, if it is over 10 feet from the bottom of the post, at the pin side, it is not a broken barrier." Continue on with the rest of the rule as it is shown in the rule book.

27. Page 24, No. 8. The last sentence should be deleted and in its place, "Cattle may be

lined by only one man."

28. Page 25, No. 12, in the first sentence, please add the following: "...; ladies breakaway roping, three fourths of the way down the arena on the right hand side."

29. Page 26, No. 17, The ten dollar (\$10) shall be changed to twenty-five dollars (\$25.00)

- 30. Page 36, No. 8, shall read as follows: "Roping calves shall weigh a minimum of 150 pounds, maximum of 300, and should be uniform in size."
- 31. Page 36, No. 14, add, "There is no time limit on timed events at the finals."

32. Page 36, No. 16, should read as follows: "Calves may be lined by only one person."

33. Page 37, No. 2, please complete the last sentence of this paragraph with "discretion of the judges."

34. Page 38, No. 15. Delete the entire rule.

35. Page 39, No. 17, add the following to the end of this paragraph: "Judges should bring the complaint to the stock contractor's attention, and if proper action is not taken a fine will be applied."

36. Page 39, No. 21, please change to, "Cattle

may be lined by only one person.'

- 37. Page 39, No. 19, please add the following: "There will be no time limit in timed events at the finals."
- 38. Page 40, No. 6, second sentence, please delete "and/or dallies."
- 39. Page 41, No. 15 (f), should read as follows: "If a front leg is in the head catch at the time of the flag, in the team roping, it is an automatic no time."
- 40. Page 41, No. 17, please add the following: "Except at the finals, there will be no time limit on any timed events."
- 41. Page 41, No. 19, second sentence, please delete the "/or."
- 42. Page 41, No. 20, add the following: "Cattle may be lined by only one person."
- 43. Page 45, No. 1, please add the following: "There is no time limit on timed events at the finals."

44. Page 46, No. 11, add the following: "Cattle may be lined by only one person."

45. Page 47, No. 3, the first sentence should read as follows: "A neck rope or similar device must be used and calf may not be busted." The fourth sentence should read, "Rope to be removed from calf's body as soon as possible after 'tie' is inspected."



## Rodeo Royal Unique

The Rodeo Royal was a unique rodeo to say the least, with two associations competing, but not against each other. The competitors in the broncs and barebacks for both associations were nearly even in percentages ridden and average scores, but the NARC bull riders overshadowed the CPRCA/PRCA riders by quite a margin.

In the timed events it was hard to compare times, as the time in the dual events starts when the green light comes on, and in the single competition time starts when the calf reaches the score line. The secretaries and timers figured that was approximately a two second starting difference. The rodeo went

well and the crowds were good.

The Calgary Stampede, July 3 through 12, will be with both associations competing again. The first half will be NARC team rodeo such as the previous two years, but with only one go-round in each event, and the second half will be CPRA/PRCA rodeo.

The decision has not been made by the Calgary board yet as to how many teams they will need for a double elimination tournament consisting of ten games. There will probably be six teams, instead of 11 as previously, but that is not definite yet. There have not been any areas designated as to where the teams will be selected. They will make the decision soon and all that information should be in the next issue of World of Rodeo and sent to each association's offices.

There will be no decision made by the Calgary Royal and Stampede board on 1982 and future years until after the Stampede has been completed and they have evaluated both rodeos.


